

TUITION AND TRANSPORTATION AGREEMENT

THIS AGREEMENT, made and entered into this 10th day of August 2020, by and between the Boards of Trustees of SCHOOL DISTRICT NO. 288, Deary, Idaho, (herein called "District 288") and AVERY SCHOOL DISTRICT NO. 394, Avery, Idaho, (herein called "District 394"), pursuant to resolutions duly passed by the respective Boards of Trustees.

WHEREAS, the Board of Trustees of District 394 has determined that it is in the best interests of certain of its pupils, as hereinafter set forth, to attend school in District 288; and District 288 has determined to accept such pupils upon the terms hereinafter set forth;

NOW THEREFORE the respective Districts agree as follows:

1. District 288 will accept, enroll and educate pupils of District 394 at any grade level who would otherwise attend school in Clarkia, Idaho.
2. District 288 will submit to District 394 an annual billing for tuition at rates determined by the State Department of Education pursuant to I.C. Sec. 33-1405.
3. Transportation will be provided by District 288.
4. This agreement shall be and remain in effect from August 1, 2020 to July 31, 2021, unless the parties hereto shall mutually agree to sooner termination or modification.



TUITION AND TRANSPORTATION AGREEMENT

ST. MARIES JOINT SCHOOL DISTRICT NO. 41 AND AVERY SCHOOL DISTRICT NO. 394

2020-2021 SCHOOL YEAR

This Agreement is made and entered into on this 10th day of ^{August} ~~July~~, 2020 by and between the Boards of Trustees of ST. MARIES JOINT SCHOOL DISTRICT NO. 41, St. Maries, Idaho, (herein called "District No. 41"), and AVERY SCHOOL DISTRICT NO. 394, Avery, Idaho, (herein called "District No. 394"), pursuant to resolutions duly passed by the respective Boards of Trustees.

WHEREAS, the Board of Trustees of District No. 394 has determined that it is in the best interests of certain of its pupils, as hereinafter set forth, to attend school in District No. 41; and District No. 41 has determined to accept such pupils upon the terms hereinafter set forth.

NOW, THEREFORE, the respective Districts agree as follows:

1. District No. 41 will accept, enroll, and educate pupils of District No. 394 at the secondary level (grades nine through twelve) and District No. 394 pupils at any grade level who require and qualify for Special Education.
2. District No. 41 will also accept, enroll, and educate pupils who would otherwise attend school in Clarkia, Idaho.
3. District No. 41 will submit to District No. 394 an annual billing for tuition at rates determined by the Idaho State Department of Education pursuant to Idaho Code Section 33-1405.
4. Cooperative arrangements between the Districts will include transportation provided by District No. 41 for elementary, middle, and high school students from the Clarkia, Idaho area to the UpRiver School, Fernwood, Idaho, St. Maries Middle School, and St. Maries High School, St. Maries, Idaho. District No. 394 will provide transportation for students from the Avery, Idaho area and those along the St. Joe River Road route from the Shoshone County/Benewah County Line to St. Maries High School, Heyburn Elementary School, and St. Maries Middle School in St. Maries, Idaho. St. Maries Joint School District No. 41 will provide the labor for the following mechanical services on District No. 394's bus at no charge:
 - A. Performance of all normal bus maintenance, with District No. 394 to pay for all parts and materials;
 - B. Oil changes, with District 394 to pay for oil, filters, and disposal fees;
 - C. Labor for all minor repairs that District No. 41 mechanics are capable of performing, with District No. 394 to pay for parts and materials;
 - D. Support for all records maintenance for District 394's bus in the same manner required for maintenance for District No. 41's fleet per State requirements.
 - E. Completion of State-required 60-day and annual inspections;
5. This Agreement shall be and remain in effect from July 1, 2020 to June 30, 2021, unless the parties hereto shall mutually agree to sooner termination or modification.

SPECIAL EDUCATION INTER-DISTRICT AGREEMENT

**ST. MARIES JOINT SCHOOL DISTRICT NO. 41
AND
AVERY SCHOOL DISTRICT NO. 394
2020-2021 SCHOOL YEAR**

This Agreement is made and entered into on this 10th day of August, 2020 by and between St. Maries Joint School District No. 41, Benewah and Shoshone Counties, Idaho, and Avery School District No. 394, Shoshone County, Idaho, and is for the purpose of serving Preschool-8 Special Education students that attend Avery School District No. 394.

St. Maries Joint School District No. 41 agrees to furnish the following services:

1. Special education instruction for students who qualify for special education and/or related services.
2. Counseling services for special education students who qualify for related services.
3. Psychological services for students who qualify for special education and/or related services.
4. Speech/Language services for students who qualify for special education and/or related services.
5. Assistance for Child Find Activities for Avery School District No. 394.

Avery School District No. 394 agrees to the following:

1. Pay tuition and ancillary costs as necessary to serve special education students.
2. Child count will be the property of St. Maries Joint School District No. 41.
3. Pay mileage for staff that travels to Avery School District No. 394 for assessments/services based on the Idaho State mileage rate.
4. Furnish transportation for special education students attending St. Maries Schools.
5. Participate in St. Maries Joint School District No. 41 Child Find process and reimburse costs associated therewith to St. Maries Joint School District No. 41.

The duration of this Agreement shall begin July 1, 2020 and run through June 30, 2021, and from year to year thereafter, unless terminated by agreement of both parties.
